4. ANNUAL REPORT 2022

President's report - Joan Thompson

This was Joan's final year as President and she reflected on her 4 years as a member and 3 plus years as President. Joan talked about the good that change can bring and urged members to become or remain actively involved in the organisation of our U3A so that it continues to thrive. Joan thanked all members, the Committee and the wider community for their support over this journey.

Secretary's report - Fiona Williams

- MEMBERSHIP: Growth continues with a trebling of members since 2019. Much of the growth has been word of mouth a great reflection on all involved in our U3A.
- COMMITTEE: The establishment of Working Groups (specific purpose time-limited projects)
 and Teams (to support ongoing functions) has been important not only for sharing the
 Committee's load but allows active participation of more members in the Association's
 organisation. It also allows for members with specific skills to contribute.

Membership Support Team report - Carol Neumann presented on Carol's behalf by Sue Sturup New initiatives have been introduced to look after members, including a welcome morning tea for new members half way through the year. The membership team also undertook external activities to showcase U3A HBW to the broader Hobsons Bay Community. In her report, Carol thanked the Membership Support Team along with all members.

Grants and UMAS reports - Sue Dawkins

GRANTS: Grant success continues to be extremely important in contributing to our costs and growth, noting that 36% of income in 2022 was sourced from grants. Generous financial support in 2022 was provided in particular by Hobsons Bay City Council, Bendigo Bank and Viva Energy. On behalf of the Committee, Sue thanked Hobsons Bay Council, Bendigo Bank and Viva Energy for their generous financial support. See detailed breakdown on page 10.

UMAS: UMAS, the online management system used by U3A, is working well for members and convenors. 95% of enrolments for 2023 were undertaken online via UMAS. FAQs are available on the website for both members and convenors.

Activity Coordinator's report – Sue Dawkins

Sue highlighted the ongoing amazing growth in activities, with a significantly increased range of topics and delivery formats. Significant growth has occurred in one-off activities and short-term activities (two to eight sessions per activity). Of the 89 activities in 2022, 55 were new activities. Sue noted that this rapid expansion of activity offerings has only been possible because of the wonderful members who volunteer to convene or co-convene activities. The range of activities we have been able to offer showcases the talented membership, with their diverse career backgrounds and life experiences. The introduction of co-convenors has been a great initiative in 2022, allowing the load of convenors to be shared. Most on-going activities now have co-convenors.

Venues report - Ian Barclay



Ian provided an update on venues, noting that Bayview Pavilion and Digman Reserve have now joined the Cottage in becoming significant venues used by U3A HBW. There are of course many other venues and the use of these is tracked. The Senior Citizens' Centre is to be rebuilt as a multi-purpose hub and Ian noted that U3A Williamstown has been actively involved in the consultation and planning phase for the new building.

Action Plan - progress report - Sue Dawkins

Sue provided an update, noting that we have certainly met the listed goals and targets and noted that the next consideration for the Club is to determine what size it wants to be. See the document provided with the AGM papers for full details.

8. SURVEY OF CONSTITUTIONS OF 12 VICTORIAN U3As

As background to Item 9, Sue Dawkins reviewed the rules relating to restriction on re-election for the 12 Victorian U3As which provide their constitution on their website. Of these, all adopt the Consumer Affairs Victoria Incorporated Association Rules. None restrict the re-election of ordinary committee members but some limit the re-election of officer bearers eg President. She clarified

9. PROPOSED AMENDMENT TO THE CONSTITUTION - SPECIAL RESOLUTION

Proposer: Ruth Patching **Seconder:** Sandy Guest

Special Resolution: That Rule 55 Term of Office, sub-rule 2: 'A committee member may be re-elected'

be altered to state that: a committee member may be re-elected for a maximum of four consecutive elections with the following provisions:

- 1. All members elected at the 2023 AGM will be considered to be in their first term.
- 2. To allow for continuity of Committee membership, for the period of adjustment to the new regime, it is preferable to have no more than three committee positions vacated in any one year.
- 3. If more than three committee members who have served the maximum four years do not wish to retire, the committee shall decide which three members shall retire.

Refer to the Agenda for detailed background.

Item 9 was conducted as follows:

- 1. The proposer reads out aloud the Special Resolution (2 minutes max)
- 2. The seconder may comment at this time or later in the period prior to the vote (1 minute max)
- 3. Comments from the floor (1 minute max per person)
- 4. The proposer has the final right of reply.
- 5. The vote is taken.

Per the U3A HBW Constitution, in order for a Special Resolution to be passed a minimum of 75% of those voting on the day (in person at the meeting or via a proxy) must vote in favour.

At the meeting, 43 voting members were present and 37 proxies had been presented = total of 80 therefore requiring at least 60 votes to pass the Special Resolution.

There was much discussion with several members commenting on the importance of renewal for the long-term. 2 members commented on an apparent anomaly in the wording (re-election for a maximum of 4 consecutive years implies 5 years [the initial year + 4 years re-elected]).

Results of voting

The written votes were counted by John Adams, Returning Officer. The results were as follows:

- YES (i.e. support the Special Resolution) = 39
- NO (i.e. do not support the Special Resolution) = 28
- ABSTAIN = 1
- Note: not all members voted

The Special Resolution was not passed.



An amendment to the wording was discussed – President Ann Banham advised that amendments would not be accepted at the AGM but could be considered following the AGM.

10. ITEMS WITHOUT NOTICE

Kerry Lewis submitted a request that the new Committee call a Special General Meeting to consider an amended Special Resolution (see Item 9).

"That the Committee call a Special General Meeting within 4 months to put the proposed amendment with the deletion of the word 're' and any other minor changes to the Special General Meeting."

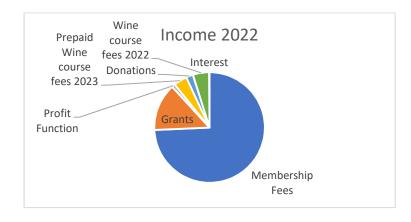
12. GUEST SPEAKER Cr Pamela Sutton-Legaud (HBCC)

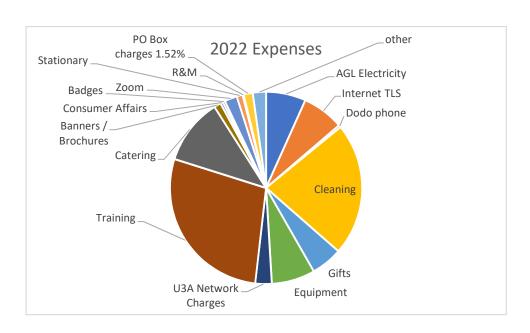
